Requirements to Use Essential Cloud Plan

A subscription to the Essential Cloud Plan is included with your purchase of a ChargePoint CPF50 charging station ("**Charging Station**"). Your access and use of the Essential Cloud Plan is subject to the then-current form of ChargePoint Master Services and Subscription Agreement ("**MSSA**") and the following supplemental terms and conditions ("**Essential Cloud Plan Terms and Conditions**"):

- 1. Your use of the Essential Cloud Plan with each Charging Station constitutes your acceptance of the Essential Cloud Plan Terms and Conditions. Your acceptance of the MSSA is subject to the terms and conditions of the MSSA. Any defined terms not otherwise defined herein shall have the meaning defined in the MSSA.
- 2. As part of your use of Flex Billing, you must set a minimum price for Session Fees (per kWh pricing) for Charging Sessions used through the Charging Station. ChargePoint's payment to you of Net Session Fees will be subject to the MSSA and the Essential Cloud Plan Terms and Conditions.
- Any Net Session Fees that you accrue during the time periods described in the Fee
 Offset Policy will be used by ChargePoint to offset any fees for upcoming Cloud
 Plan renewals you owe during the aforementioned time periods. The offsetting is
 governed by the <u>Fee Offset Policy</u>.
- 4. In the event of conflicting terms and conditions between the MSSA and the Essential Cloud Plan Terms and Conditions, then the Essential Cloud Plan Terms and Conditions will supersede and govern solely in the event of such conflicting terms and conditions.
- 5. ChargePoint reserves the right to modify, from time to time, the Essential Cloud Plan Terms and Conditions. Your continued use of the Essential Cloud Plan after

any such modification will constitute your acceptance of then-modified Essential Cloud Plan Terms and Conditions.

Access to the ChargePoint® Network	Serving over a million EV drivers, the ChargePoint Mobile App and driver portal enable EV drivers to find available stations, start charging, get charging session updates, view and upload station pictures, report station issues and more.

Network Connectivity (4G LTE)	Reduces installation costs by eliminating the need for WiFi or gateways at the site.
24X7 Driver Support	ChargePoint provides 24/7 support to EV drivers over the phone and via email.
24X7 Host Support	Supports station hosts 24/7 over the phone and via email.
Automatic station software updates	Downloads software upgrades over the air so the latest features and performance enhancements are available.
